- Staff would really like more time to collaborate and work together to tackle issues and classroom tasks
- Staff would like to propose doing 4 full days of school and 1 day to gather each month. SCS typically goes over in hours and it may not affect our required days.
- Possibly start this January 12th
- Discussion around Mondays, Fridays or middle of the week.
- Would SCS offer before and after school care.
- Possible to bring in someone like 7 Rivers to watch kids for the day.
- Worry about multiple half days for children's wellness and an additional day for collaboration is a lot of time from learning.
- Talk about moving to January 3rd to have right after break.
- More talk about possibly adding a day in December
- Alot of talk about half day vs full day, and how the time off would affect kids that need routine.
- Came up that 20 minutes in morning that teachers had to collaborate have been lost do to shortages in staff and COVID
